- Loan Application
- Share Withdrawals
- Transfers either manually or on Vale of Leven Credit Union Database
- Bank Transfers (to your personal bank account) of Shares/Loans at YOUR request/instruction.
- Transfer of Shares/Loans onto the pre-paid Engage Card at YOUR request/instruction.

<u>YOU</u>, (The Member), are responsible for maintaining that your personal details remain correct. Therefore, you should notify Vale of Leven Credit Union Ltd of any changes at the earliest convenience. All changes will have to be accompanied by proof & signature (where applicable).

## **YOU** (the member)

- a) Have a right to request what information Vale of Leven Credit Union Ltd hold about you and will provide you with a copy, in line with the General Data Protection Regulation E.U. Directive My 2018.
- b) Have the right to 'close' your account, providing there is no outstanding Loan balance.
- c) Have a right to withdraw consent.
- d) Have a right to complain if you consider, that our processing of your personal information infringes data protection laws. (See Foot of this page).

## WE Vale of Leven Credit Union Ltd.

- 1. Will contact you ASAP if <u>WE</u> discover any differences, to enable the correct information to be established.
- 2. Will <u>always</u> require answers to security questions, if you contact us by phone. The questions will only relate to information provided when you opened the account.

The confidential information we hold about you should only be disclosed outside Vale of Leven Credit Union Ltd,:

- At the Member's request or with your consent
- To investigate or prevent fraud
- If the law permits it or it is in the public interest.

## **ID For YOUNG Members (Under 16 years)**

The information we hold, for you to open an account would be in the form of a birth certificate. This information would have been presented to Vale of Leven Credit Union Ltd in the form of a birth certificate by a Parent or Guardian. The Parent or Guardian has the same rights as above, for any account held in YOUR name. This is until the age of 16 years is reached. After which, the Young Member takes responsibility of their own details.
